This lack of visibility extends to public AI usage. 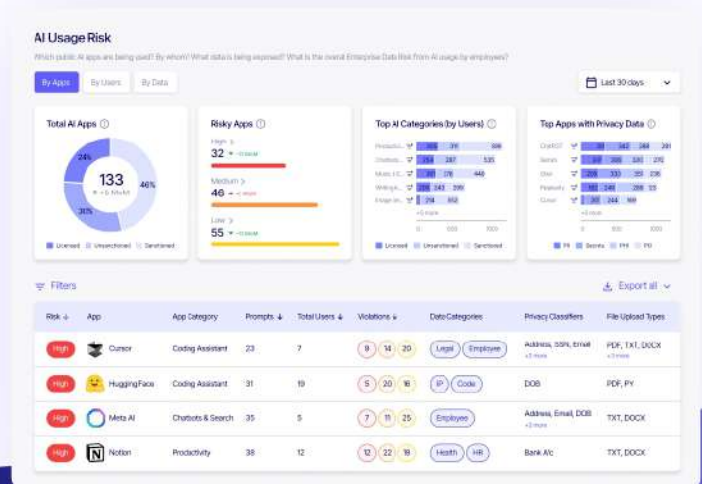

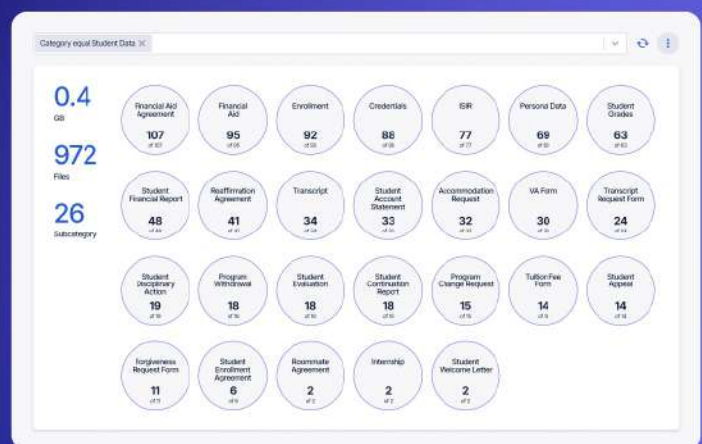
